## Location

Clifton Mills is located just off the A641 close to the junction of Bradford Road (A641) with Birkby Lane near the centre of Bailiff Bridge. The property is only a short distance from Brighouse town centre, with nearby occupiers on Bradford Road including B&M Bargains and McDonalds drive thru.

Clifton Mills is accessed directly off the main Bradford Road and benefits from convenient access to the M62 motorway. Junction 25 of the M62 (Brighouse) is approximately 3 miles to the south east and Junction 26 (Cleckheaton) is a similar distance to the north east.

## Description

Clifton Mills complex comprises a multi occupied ground floor complex which has been split into various units, with unit 11 being the last remaining vacant unit. The premises include a steel roller shutter door to open plan workshop/storage space under a pitched north light roof, along with internally partitioned office area.

Externally the multi occupied premises benefit from a covered loading / parking area along with additional parking available within the macadam surfaced shared yard area off Bradford Road.

## Services

We are advised that mains water, sewer drainage and a electricity supply are connected to the property in addition to independent appliances including lighting. However no tests have been carried out on any of the aforementioned services or appliances and therefore we are unable to comment as to their condition or capacity.

## Rating

We are advised by the Valuation Office website Unit 11 is assessed as RV £7,600.
